INSTRUCTIONS AND APPLICATION FOR RECOGNISATION OF STUDY CENTRE TO RUN B.Ed (ODL) COURSE

INSTRUCTIONS

- 1 The application should be filled in carefully as per the NCTE norms to run the B.Ed (ODL) course and enclose a DD for Rs.10,000/- (Rs. Ten thousand only) towards processing fee and other expenditure for inspection. In favour of The Director Directorate of Distance Education MGAHV payable at Wardha.
- 2 The application should reach to the Director, Directorate of Distance Education on or before last date prescribed for the same.
- 3 Before filing application for recognition, the institute should ensure that, the college has recognised by the NCTE and also is affiliated with recognised University with full infrastructure and faculties.
- 4 The M G A Hindi University reserves the right to accept or reject any of the application/s without assigning any reason.
- 5 The following category of institution shall qualify to become a Study Centre :-
 - a) Existing Teacher Education Institution recognized by NCTE for offering the same programme in face-to-face mode and having all the requisite infrastructure and staff as per NCTE norms, institutions having offered the relevant teacher education course for at least last five years. Institutions declared as Study Centre for one course/programme by a University shall not be the Study Centres for any other programme of the same or any other University/Institution.
 - a) (i) The number of students allotted to a Study Centre shall not exceed fifty.
(ii) The Study Centre shall provide to the distance learners (allocated to it) access to its library, laboratories and other physical facilities,
(iii) The Headquarters or the Regional Centre of the ODL institution may also function as a Study Centre at least for one hundred (50 first year and 50 second year) students.
 - b) Teacher educators/supervisors/academic counsellors engaged for various activities of the Study Centre shall be fully qualified as per the NCTE norms.
 - c) All the functionaries associated with the activities of the Study Centre must be oriented by the open university/institution in the practice of the ODL system from time to time, but at least once in a year.
- 6 Further, the recognition is subject to fulfilment of the requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government, etc. as applicable.
- 7 The institution shall submit a Self-Appraisal Report to the Regional Committee at the end of each academic year along with the statement of Annual Accounts duly audited by a Chartered Accountant.
- 8 The institution shall maintain and update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure :-
 - a. Sanctioned programmes along with annual intake in the institution.
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualification, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last quarter.
 - d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journal subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information. If it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
