

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalay, Wardha (Central University), Plot Number: 18, Village: Umari, Post Office: Manas Mandir, Tehsil/City/District: Wardha: 442001, Maharashtra has by affidavit consented to come under new Regulations and sought recognition for a basic unit of B.Ed. (ODL) which require additional facilities.

3. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,

- (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate(LUC) and the Building Plan(BP)in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- (iii). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalay, Wardha (Central University), Plot Number: 18, Village: Umari, Post Office: Manas Mandir, Tehsil/City/District: Wardha: 442001, Maharashtra for conducting B.Ed. (ODL) programme of 2 years duration for an annual intake of 500 students for session 2015-2016 subject to the condition that one study centre shall enroll not more than 50 students in a given session subject to fulfilment of the conditions mentioned herein before 31.10.2015.

5. Further, only the following category of institutions shall qualify to become a Study Centre:-

- (a) Existing Teacher Education Institutions recognized by NCTE for offering the same programme in face-to-face mode and having all the requisite infrastructure and staff as per NCTE norms; institutions having offered the relevant teacher education course for at least last five years. Institutions declared as Study Centre for one course/programme by a University shall not be the Study Centres for any other programme of the same or any other University/Institution.

- (b) (i) The number of students allotted to a Study Centre shall not exceed one hundred (50 for the first year and 50 for the second year), (ii) The Study Centre shall provide to the distance learners (allocated to it) access to its library, laboratories and other physical facilities, (iii) The Headquarters or the Regional Centre of the ODL institution may also function as a Study Centre at least for one hundred (50 first year and 50 second year) students.
 - (c) Teacher educators/supervisors/academic counsellors engaged for various activities of the Study Centre shall be fully qualified as per the NCTE norms.
 - (d) All the functionaries associated with the activities of the Study Centres must be oriented by the open university/institution in the practice of the ODL system from time to time, but at least once in a year.
 - (e) The request for additional unit of intake in any programme shall be examined by the NCTE on the basis of availability of required facilities in respect of study centres and related support in the territorial jurisdiction of the institution. Laid down procedures shall be followed for seeking recognition for additional intake.
6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
 - l) NCTE, New Delhi vide letter no. F.49-15/2013/NCTE/N&S dated 12th September, 2013 has granted relaxation to Central Universities under clause 12 of extent NCTE (Recognition Norms & Procedure) Regulation 2009 that the infrastructural requirements shall be fulfilled within a period of 3 years; provided adequate infrastructural arrangement is made on lease/rental basis as per be stipulations of NCTE, before approval.

In case, at the end of 3 years all the criteria, as per the Rules and Regulations of the NCTE are not fulfilled, the Regional Committee would be at liberty to withdraw the recognition given to the respective Central Universities.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
